DIRECTIONS FOR USE:

Use only as directed

For use on common Cynodon turf varieties eg, Hall's Selection, Skaapplaas, Bermuda, Rietondale and Kikuyu grass planted to lawns, sport fields, golf courses, greens and pavings etc.

Apply after weed emergence when the plants are in active growth stage and when conditions are ideal for plant growth. Scatterkill for weeds should be applied evenly over the area to be treated at a rate of 50 g/m² and watered afterwards. This will release the herbicides from the granules and move them into the root zone of the young weed plants. Rain following application will not adversely affect the treatment. Control of weeds through the root system may delay the visual effect of dying plants but growth is retarded and the weeds will die over a number of days. For the control of persistent annual broadleaf weeds repeat treatment alter 3-4 weeks or as necessary when new weeds germinate.
